**Time (fact):** 11:39 hrs (Time of the incident)  
**Session:** Race 2  
**Fact:** Each of the cars entered Pit Lane to commence Mandatory Pit Stop before crossing the control line after the display of the green flag at the end of a safety car deployment when the MPS pit window had been delayed.  
**Offence:** Breach of Article 20.1.2 of the Monochrome GT4 Australia Sporting Regulations  
**Decision:** 20 second time penalty  
**Reason:** A safety car deployment caused the delay in the opening of the Mandatory Pit Stop window. When the green flag was displayed at the end of the safety car deployment, several cars entered Pit Lane to complete their MPS without having first crossed the control line. The circumstances were unusual and each team manager had believed that it was not improper to commence the Pit Stop.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Motorsport Australia NCR's, within the applicable time limits.
